ORDER:

Section 22 of the Building & Other Construction Workers (RE&CS) Act, 1996, empowers the Telangana Building & Other Construction Workers Welfare Board, Hyderabad, which was constituted under the provisions of the Act, to provide certain welfare measures and facilities to the building and other construction workers.

2. In the circumstances reported by the Secretary & Chief Executive Officer, Telangana Building & Other Construction Workers Welfare Board, Hyderabad and after careful examination, the Government hereby order to approve the scheme under sub rule (L) of Rule 33 of the State Building & Other Construction Workers Welfare Rules, 1999, read with section 22 (h) of the Building & Other Construction Workers (RE&CS) Act, 1996 to provide artificial limbs, wheel chair / tricycle and fabricated appliances to the registered building & other construction workers who lost their limbs in an accident that occurred either in the work place or anywhere else resulting in disability. The artificial limbs, wheel chair / tricycle and fabricated appliances shall be arranged from M/s. Artificial Limbs Manufacturing Corporation of India, Kanpur which is a Government of India organisation manufacturing the artificial limbs and other auxiliaries to the persons with disability.

3. The Scheme shall come into force w.e.f 01.05.2016 with the following conditions & guidelines:-

- 1) The beneficiaries of the scheme shall be the registered building & other construction workers.
- 2) The scheme shall be applicable only to the accidents that took place on or after 01-05-2016.
- 3) The copy of the BOC registration card and AADHAR card of the registered worker shall be submitted along with the application form.
- 4) The attested Xerox copy of the Medical reports along with Disability Certificate issued by the Medical Board shall invariably be submitted along with application to the concerned Asst. Labour Officer who shall recommend to the Deputy Commissioner of Labour.
- 5) The Deputy Commissioner of Labour shall place the application before the District Screening Committee for scrutiny.

- 6) After scrutiny, if the claim found eligible, the Deputy Commissioner of Labour shall address the Regional Office of M/s.Artificial Limbs Manufacturing Corporation of India at Hyderabad for arranging the artificial limbs, wheel chair / tricycle and fabricated appliances depending upon the requirement of the disability of the worker.
 - 7) The payment of artificial limbs, wheel chair / tricycle and fabricated appliances shall be made directly to M/s. Artificial Limbs Manufacturing Corporation of India through its regional office at Hyderabad.
 - 8) The application along with its enclosures after arranging the limbs and payment particulars to the agency shall be kept as permanent records in the office of the Deputy Commissioner of Labour for inspection.
 - 9) The Secretary & CEO, Telangana Building & Other Construction Workers Welfare Board shall prescribe the application form for sanction of the relief.
4. The Commissioner of Labour, Telangana, Hyderabad and the Secretary & Chief Executive Officer, Telangana Building & Other Construction Workers Welfare Board, Hyderabad shall take necessary action accordingly.
5. This order does not require concurrence of Finance Department as per rules in force.
