Labour, Employment, Training & Factories Department – The Building and other Construction Workers (RE&CS) Act, 1996 – Implementation of Welfare Schemes by the Telangana Building and Other Construction Workers Welfare Board – Scheme to provide relief to the nominee / dependants / legal heirs of the deceased registered building & other construction worker in case of natural death – Enhancement of amount from Rs.60,000/- to Rs.1,00,000/- – Orders – Issued.

ORDER:

In the G.O. 5th read above, the Government have issued orders to enhance the existing amount from Rs.30,000/- (Rupees thirty thousand only) to Rs.60,000/- (Rupees sixty thousand only) towards relief to the nominee / dependants / legal heirs of the deceased registered building & other construction worker in case of natural death with certain guidelines w.e.f. 01.05.2015.

2. In the letter 6th read above, the Commissioner of Labour, Telangana has submitted a proposal for enhancement of the beneficiary amount under the welfare schemes “Natural Death” from Rs.60,000/- (Rupees sixty thousand only) to Rs.1,00,000/- (Rupees one lakh only) towards relief to the nominee / dependants / legal heirs of the deceased registered building & other construction worker in case of natural death with certain guidelines w.e.f. 01.05.2018. Since the entire expenditure will be met from the funds of the Telangana Building and Other Construction Workers Welfare Board and there will be no financial burden to the Government Ex-Chequer.

3. In the circumstances reported by the Commissioner of Labour, Telangana, Hyderabad and after careful examination of the proposal, Government hereby enhance the beneficiary amount under the welfare scheme “Natural Death” from Rs.60,000/- (Rupees sixty thousand only) to Rs.1,00,000/- (Rupees one lakh only) towards relief to the nominee / dependants / legal heirs of the deceased registered building & other construction worker in case of natural death in terms of sub rule (L) of Rule-33 of the Telangana Building & Other Construction Workers (RE&CS) Rules, 1999 read with Section 22 of the Building & Other Construction Workers (RE&CS) Act, 1996 with the following guidelines w.e.f. 01.05.2018:

- (i) The Scheme is applicable to the registered building and other construction worker as a beneficiary with the Board.
- (ii) An amount of Rs.1,00,000/- (Rupees one lakh only) shall be paid as relief to the nominee / dependant / legal heir of the deceased worker in case of natural death of the registered building and other construction worker.

- (iii) The funeral expenses if not paid before funeral rites, the same shall be paid along with the natural death relief amount.
- (iv) The enhanced amount of death relief is applicable only to the deaths took place on or after 01.05.2018.
- (v) Relief under this scheme is in addition to other relief / compensation that the worker may be entitled to under any other Scheme.
- (vi) The nominee / dependant / legal heir of the deceased worker shall submit prescribed application form to the concerned officer along with original Building and Other Construction Workers Welfare Board registration card, Death Certificate and the supporting documents i.e Household ration card / Adhar Card issued by the competent authority as a proof of the nominee / dependant declared by the worker in his registration application form. In case of no nominee or dependant claims the amount, the legal heir of the deceased shall submit the legal heir certificate to claim the benefit amount under the scheme along with the above documents.
- (vii) The Nodal Officer concerned shall obtain enquiry report from Assistant Labour Officer concerned and after scrutiny, if claim found eligible, the scheme amount of Rs.1,00,000/- (Rupees one lakh only) shall be released to the saving bank account of the nominee / dependant / legal heir through online.

4. This order issues with the concurrence of Finance Department vide their U.O.No.02571/93/A2/EBS.X/2018, Dated: 04.06.2018.

5. The Commissioner of Labour, Telangana, Hyderabad / Secretary & Chief Executive Officer, Telangana Building and Other Construction Workers Welfare Board, Hyderabad shall take further necessary action in the matter accordingly.
